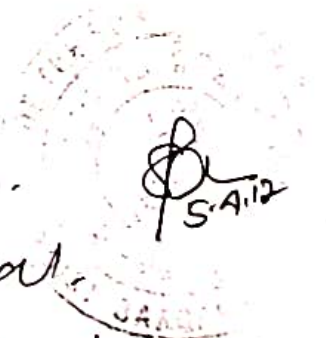

The address of the registered office may be changed after a decision of the trustees.

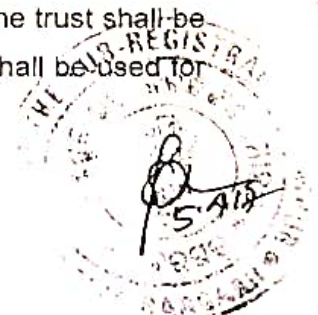
That the branch office may be established at other places after a resolution of Trustees.
